Application Checklist 2012-2013

Covenant High School welcomes international students who are interested in a Christian high school education. The following checklist will help you to complete the application process.

Step 1: Items necessary to be considered for admission

- \$100.00 Application Fee
- Student Application
- Parent Application
- Official transcript from previous two years of school
- Transcript Translation into English
- Reference Form: Teacher
- SLEP test (Secondary Level English Proficiency Test) score results

Step 2: Items due upon acceptance

- Copy of bank statement showing adequate funds for one year of education
- Copy of Passport
- \$600 Registration Fee (due upon acceptance)

Step 3: I-20 will be forwarded to applicant by CHS after steps 1 and 2 are complete

Step 4: Items due 6 weeks prior to arrival at CHS

- Home Stay Application form (if you want us to arrange a home stay family)
- Health immunization form
- Copy of medical insurance card or proof of USA illness/accident coverage

Tuition and Fees 2012-13 for International Students

Application Fee - \$100.00

Application fee covers the cost of application evaluation, document preparation and return of acceptance documents. Application fee is payable at the time the application is submitted and the fee is non-refundable. (Application fees remain non-refundable if the application is accepted but the student is unable to obtain a U.S. Visa.)

Registration Fee - \$600.00

Registration fee is due upon acceptance. I-20 will be issued after all documents and the registration fee are received. Half of the registration fee will be refunded if U.S. Visa is denied.

Yearly Tuition - \$9,900.00 (due by August 15th)

Tuition includes all regular course work, the use of books and local field trips. Tuition for the entire school year must be paid in full before the student is allowed to enter classes. Yearly tuition is non-refundable.

Late Payment Policy

- If payment is more than 14 calendar days late, there will be a late fee of \$300.00.
- If payment is more than 21 days late, the F-1 visa status may be revoked.

Host Family Fees - \$8,200 (due by August 15th)

Host family fee covers lodging, food (when prepared at home) and transportation to and from school if a bus is not available. The student is responsible for their own costs for tutoring, long distance telephone, internet, medical care, choir outfits, private music lessons, entertainment, special foods, cosmetics, TOFEL and SAT or ACT testing. Payment for home stay is paid directly to Covenant High School. The school then pays the host family. If a student withdraws before completing the full school year, the host family fee will be refunded on a pro-rated basis minus an \$800 fee.

Insurance

Illness/Accident Insurance with **coverage while in the U.S. is required** for international students. Please provide proof of insurance for coverage in the U.S. The insurance policy should provide coverage for medical expenses totaling at least up to \$250,000.00. CHS International Student Host Family Guidelines

- Host families are to provide a warm and nurturing environment for the international student. Their commitment to host is understood to be for the current year only.
- Students are to arrive at the host family home no sooner than 5 days before the first day of school and are depart the host family no later than 5 days after the school year ends.
- The Host Family Fee covers lodging, food (the student is expected to eat the meals prepared by the host family) and transportation to and from school if a bus is not available. Host families will pick up the student and bring the student to the airport when arriving to or exiting from the USA.
- Home stay fees are paid directly to Covenant High School. The school then pays the host family.
- The student is responsible for their own costs for tutoring, long distance telephone calls, internet, medical care, Choir outfits, private music lessons, entertainment, eating out, special foods, cosmetics, TOFEL and SAT or ACT testing, etc...
- Students are responsible to supply their own computer, printer, printer supplies and paper.
- Host parents may restrict the student's personal computer and phone usage if they deem it necessary to ensure success in school or in order to ensure the proper amount of sleep.
- Students must obey the host family's rules and accept the consequences for misbehavior. Students will be expected to perform typical household chores like any other member of the host family. Students are expected to do their own laundry.
- Host families are not responsible for transportation to tutoring, or any activities outside of the school day. If the student is not ready to leave the house in the morning to arrive at school on time, the host family may depart for school without the international student and the student will be responsible for getting himself to school.
- If the student has visiting natural family members, they are not permitted to stay with the host family. They must make other arrangements for food and lodging.
- Under no circumstances is the host family to permit the student to drive the family car or include the student on any of the family's insurance policies including medical and automobile insurance.
- Students are expected to attend church with the host family on Sunday mornings.

STUDENT COMMITMENT

5. *Submit to the authority of your parents, teachers and school officials as given to you by the Lord.*

This is a commitment of lifestyle, not just during school hours, but twenty-four hours per day and twelve months per year. Violations are considered as breaking a firm commitment that each student makes when voluntarily choosing to attend the school. As a member of Covenant High School, you will be expected to exert a positive influence in your social relationships and to be a responsible member of the Covenant High School community.
